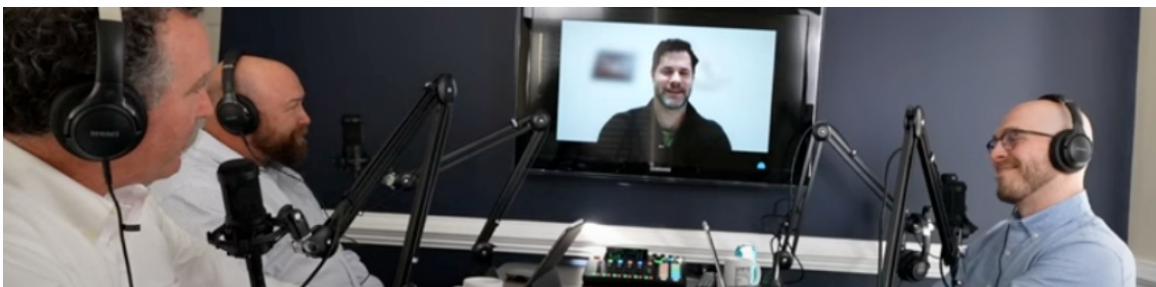
- Plan ahead – Arrange a safe ride home.

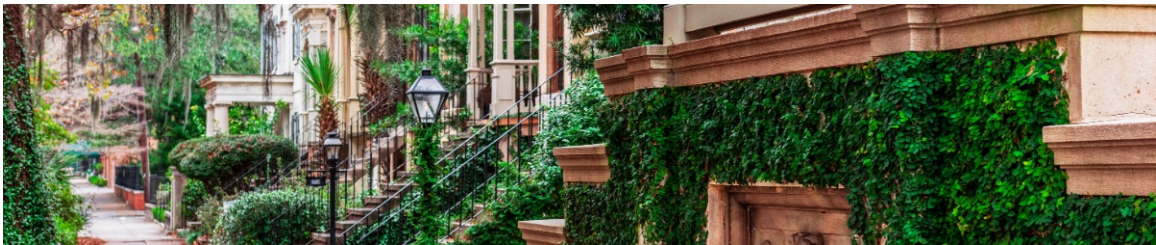

Savannah's Open Container Laws & St. Patrick's Day Celebrations □



Before you raise a glass this St. Patrick's Day, make sure you know Savannah's open container laws to avoid fines—or worse.

Where Can You Drink in Public?

Allowed: One drink (in a plastic 16-oz cup) inside Savannah's Historic District (River Street, City Market, & parts of downtown).

Not Allowed: Outside the district, in residential areas, or on private property without permission.

What's Illegal?

Glass bottles & cans in public spaces.
Carrying drinks outside permitted zones (risking fines).
Public intoxication & DUI—police strictly enforce these laws.
