Bowen Painter Heads to the U.S. Supreme Court

The U.S. Supreme Court has agreed to hear *Winston Hencely v. Fluor Corporation*, a major case co-led by Bowen Painter Injury Lawyers. This rare decision—granted in less than 1% of annual petitions—marks a pivotal moment in the fight for accountability when private defense contractors endanger U.S. service members abroad.

U.S. Army Specialist Winston Hencely was gravely injured while preventing a suicide bombing at Bagram Airfield in Afghanistan. His legal

team, including Bowen Painter's Paul Painter, Stephen Morrison, and Andrew Bowen, will argue that contractors like Fluor must be held responsible when they violate safety protocols and put American lives at risk.

Oral arguments are expected during the Court's next term. We're honored to help pursue justice on behalf of our client and all service members placed in harm's way by corporate negligence.
